1 INTRODUCTION

This volume contains proceedings from the workshop *Interactions between* syntax and semantics across frameworks, held on 8th January 2015 at the Department of Theoretical and Applied Linguistics (DTAL), University of Cambridge.

The workshop aimed to provide a forum for early career researchers working on different grammatical formalisms. Some talks explicitly compared frameworks (e.g. those by Bob Borsley¹, Luke Burke and Patrick Elliott, and Lucía Contreras-García), whilst others addressed the interaction between syntax and semantics in a single framework (e.g. those by András Bárány, J.M.M. Brown, Hannah Gibson, Georg Höhn, Moreno Mitrović, and Mark Steedman).

We would like to thank our invited speakers Bob Borsley, Hannah Gibson and Mark Steedman, and to acknowledge the financial support of the DTAL syntax cluster and the student committee of the Linguistics Association of Great Britain.

This brief introduction to the volume details the scope of the workshop. Section 2 introduces the aim of the workshop. Section 3 provides references for

the reading group preceding the workshop, and gives the workshop programme.

2 AIM OF WORKSHOP

Since the application of formal methods from mathematical logic to the analysis of natural language, pioneered by works like Chomsky (1957) and Montague (1974), syntax has seen a proliferation of theoretical frameworks which, despite superficial differences, share many common goals. High on the list is an elegant and descriptively adequate account of the relation between the syntactic structure of a sentence and its meaning.

In recent years, publications such as Joshi, Vijay-Shaker & Weir (1991) have shown that many different grammatical formalisms (e.g. Combinatory Categorial Grammars and Tree Adjoining Grammars) converge on the same class of formal languages, namely the Mildly Context Sensitive languages. Despite this commonality, research still proceeds in a largely fragmented fashion, with few platforms for discussion between syntacticians of different theoretical persuasions. Larger national conferences, such as the annual meeting of the LAGB, although theoretically diverse, tend not to be focused specifically on syntax, whilst smaller syntactic workshops and conferences are primarily organized by research groups working within a particular theoretical framework.

A small number of international events aimed at senior researchers have started to bridge this gap. One notable example was the 2013 colloquium *Workshop on Progress in Linguistics*, held in Berlin, the stated aim of which was "... to bring together researchers from various theoretical camps and discuss their frameworks and how they contribute to progress in linguistics."².

Interactions between Syntax and Semantics across Frameworks (ISSAF) sought to build on this momentum to encourage discussion and collaboration between researchers explicitly at an early point in their careers, many of whom are working on the same empirical issues but within different theoretical frameworks. To be as fruitful as possible, the workshop focused on the interaction between structure and meaning in natural language, and was preceded by a reading group covering introductory works in different grammatical formalisms.

The workshop sought to overcome the geographical distribution of potentially interested researchers across the country by:

• Collaborating on the organization of the workshop and 4-session reading group across four institutions: Birkbeck University of London, University of Cambridge, University College London, and Queen Mary University of London
